Directions: Students must complete this form to receive any Direct Student loans. Loan eligibility can be found on your award notification or on your Interact account (http://www.coastalalabama.edu/students/student_login/). **Students must apply for loans on an annual (academic year basis) basis, UNLESS a student is only attending for a single semester.** This means that students **must** fill this form out for two consecutive terms: Fall and Spring or Spring and Summer. A single term loan is subject to two disbursements during the term. Loans will only be disbursed for the terms that a student is registered for. Loans that are not disbursed do not have to be paid back. Interest does not start until loans are disbursed. First time borrowers as of 07/01/2013 (students who are borrowing a student loan for the first time or have paid off a previous student loan and have no outstanding balance on or after 07/01/2013) are subject to the following rules: 1) If a student qualifies for subsidized loans, there is a maximum time allocation of 150% for receiving the subsidized loans funds. If a student does not complete his degree by then and requires additional time, the only loan eligibility will be unsubsidized loans, and interest accruing on previous sub loan will be the student's responsibility.
